If you are given a negative decision, you have 28 days from the date of the decision to ask for an oral hearing. You or your solicitor can do this by writing to the Parole Board. If you do not ask for an oral hearing within 28 days, the decision becomes final and you will stay in prison until you are eligible for a further parole review or released automatically under the conditions of you sentence.

Form 207 - Time limits for appealing to the Court of Appeal

There are strict time limits in force for appeals which should be adhered to as out of time appeals can be difficult to proceed successfully with unless there are persuasive reasons why your appellant ' s notice (N161) or appellant's notice (FP161) was delayed later than 21 days or 7 days depending on the type of hearing you are considering appealing. For Final Orders (orders intended to end litigation) you have 21 days.
