In 2019, the Washington State Legislature passed and Governor Inslee signed legislation which required landlords to provide notice at least 14 days before initiating an eviction proceeding, and created a new notice form that landlords must send to tenants if they fail to pay rent, utilities or another periodic charge that is agreed to in the lease. The 14-day notice informs tenants of the total financial obligation alleged by the landlord.

Washington landlord tenant law requires the landlord to hold the security deposit in a trust account of a financial institution or licensed escrow agent in Washington. The landlord can combine security deposits from multiple tenants into a single account, but cannot mix the deposits with other funds.

Evictions in Oregon. Oregon landlords are empowered to evict tenants for the following reasons: Nonpayment of rent – If an Oregon tenant fails to pay rent, then the landlord may issue a 72-hour Notice to Pay or Quit, after a 7 day grace period has passed. Oregon landlords may also opt for a 5 day grace period and then issue a 144-hour Notice to Pay.

Legal Use of Security Deposit Funds: A landlord must provide the tenant with written terms in which a security deposit may be withheld at the end of a lease. A landlord cannot collect a deposit unless the rental agreement is in writing and a written checklist of pre-existing conditions and damages of the property is provided to the tenant.

The original moratorium applied only to dwellings that are captured in the Landlord Tenant Act, and prevented a landlord from evicting or seeking an unlawful detainer order; prohibited landlords from serving any eviction order, or otherwise assisting in an evictions and provided exceptions for property damage, danger posed by a person to the safety/health of others or property.
